

# Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to danceoutloudproductions.com and Dance Out Loud Productions and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Dance Out Loud Productions include danceoutloudproductions.com and DOLP. The DOLP website is a small business, ecommerce site. By using the DOLP website, you consent to the data practices described in this statement.

## Collection of your Personal Information

In order to better provide you with products and services offered on our Site, DOLP may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

If you purchase DOLP's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

DOLP may also collect anonymous demographic information, which is not unique to you, such as your:
